TREASURER'S REQUEST #2

Asked for board approval to send a letter to the Attorney General's office on behalf of the Village of Onekama Council asking them to investigate the Township of Onekama for allowing their Supervisor, David Meister and his partner Ginny Marz to run their for profit business of assessing and appraisal out of the Township of Onekama office. Drumm moved, Hendricks supported to allow this action. Roll Call- Drumm-yes, Gulch-yes, Lagerquist-yes, Hendricks-yes, **McNeil-no**. M/C.

President Blackmore asked the board to consider having the Treasurer set up ACH service for the village residents to pay their sewer bills and taxes on line (direct withdrawal) and depositing some village funds in the Village PNC bank. No interest from the Board at this time in opening an account at the PNC Bank. The Treasurer had investigated ACH service and found out this would cost the Village \$300.00 yearly + \$.35 per transaction. She will enclose a questioner with the summer taxes regarding interest in this service. The board will wait till the questioners are returned to take any action.

EXPLORE THE SHORES

Information was presented to the board on Phase#1 of the Village of Onekama Park restoration project. A public hearing will be held Tuesday, March 27-7p.m. to discuss the support by resolution for the proposed MDNR Trust Fund Grant being submitted by the Onekama Community Park and Rec. Committee. On Wednesday March 28-8a.m there will be a special council meeting to vote on this resolution of support.

ORDINANCE TO REDUCE SIZE OF BOARD

President Blackmore presented paper work to the board with regard to passing an ordinance which reduces the number of Village Trustees on the Village Council from six to four. After some discussion which included reduction in expense, increase in work load on remaining trustees it was the consensus of the board to leave the size of the council at six.

ORDINANCE #44, Ordinance repealing or confirming repeal of outdated or obsolete Village Ordinances

Hendricks moved, Drumm supported to adopt Ordinance #44 which repeals the ordinances that are obsolete, unused, or superseded by state law or other ordinances. M/C. The complete list is attached.
